Moundsville Building Commission Vacancy.

Three vacancies exist on the Moundsville Building Commission. Michael Lauter expressed his willingness to serve another term. The two other vacancies will be advertised.

Tri Energy Oil & Gas Property Acquisition.

Manager Hendershot informed council that Tri Energy Oil & Gas Property Acquisition would like to purchase drilling rights to two areas of property owned by the City of Moundsville. The areas will be at the old landfill site and Valley Fork North. Manager Hendershot will follow up with WV DEP for permission to utilize the landfill site as we did with the timbering.
