16	Director Thomas Dobbs and City Clerk Hewitt.

22	Councilperson Wood made a motion to accept and approve the minutes of the regular council
23	meeting of April 3, 2007, seconded by Councilperson Lemasters. Motion carried unanimously.

25	GENERAL PUBLIC HEARING:

27	* Debra Magers, 1312 Third Street, expressed concerns of the now vacant property at 215 Ash
28	Avenue. Reports of rodents, roaches, decayed rodents, animal feces etc. Ms. Magers presented
29	council with photo's and letter from Department of Health & Sanitation.

31	* Robert Blake, 1400 Third Street, supports Ms. Magers' statements and concerns. He would
32	also like something done with the property. Also reported bagged garbage in the garage of the
33	apartment.

35	* Kevin Robinson, 213 Ash Avenue, shared his concerns and frustration that he and neighbors
36	are dealing with. Neighbors have spent hundreds of dollars to exterminate their property and
37	homes.

42	City Manager Hendershot asked Ronda Francis of the Marshall County Health Department to
43	enlighten council and neighbors of the Health Departments findings. Ms. Francis stated after

speaking to the experts from the WV Department of Human Resources, Bureau for Public Health, the house at 215 Ash Avenue is not considered a Bio-Hazard. Bio-Hazard would be diseases such as anthrax or the plague. There is solid waste at the residents which would be removed and properly disposed of the same as other solid waste in a landfill.

Mayor Wallace expressed that he feels bad for the neighbors in that area and believes the City Manager and other officials of the city are doing everything they can at this point.

Manager Hendershot reported that the inspection that was conducted noted the house was structurally sound. The city's condemnation process does not mean the building would be razed. The building, being sound, would need to be exterminated, baited and cleaned out, disposing of the garbage by the property owner.

Councilperson Wood commented that if the property is sold, the city would make sure the property procedure is followed in cleaning up the property.

* Brenda Purdy, 1404 Third Street, asked council who owns the property? They can not address the owner if they don't know who it is.

Attorney White instructed Mrs. Purdy to read the will at the Marshall County Court House. The will should tell who the property belongs to.

* Linda Robinson, 213 Ash Avenue, stated that two years ago she called the city to have something done about the roach problem on the property. She also reported she spent hundreds of dollars for exterminators.

* Della Deskins, 318 Olive Avenue, addressed council on several matters; cats running loose, buildings that need demolished and certain days for the street cleaner.

* Elwood Cecil, 1205 Fifth Street, reported receiving a letter in his mailbox from the new owners of 1201 Fifth Street. Mr. Cecil also presented a petition with signatures from residents opposing the intent to place a funeral home at 1201 Fifth Street.

Councilperson Lemasters made a motion to receive and file the petition, seconded by Councilperson Wood. Motion carried unanimously.

Mayor Wallace stated this matter will be discussed at the Zoning Appeals Board Meeting.

Residents need to attend the meeting to express their concerns of the Funeral Home. He also stated if the Zoning Appeals Board approves the home, residents can appeal the matter to Circuit Court.

* Hilda Blake, 1200 Sixth Street, reported this Funeral Home will be in her back yard and she is very upset that someone would even consider this in a residential area.

Councilperson Lemasters made a motion to send a letter to the Zoning Appeals Board expressing their opposition to place the funeral home at 1201 Fifth Street, seconded by Councilperson Haynes. Motion carried unanimously. * Holly Hobbs, 1203 Fifth Street, stated that she lives beside 1201 Fifth Street and opposes the business in a residential neighborhood. * David White, 406 Clinton Avenue, reported kids throwing eggs at cars and requested patrol. * Beverly Conner, 331 Thorn Avenue, addressed council on the proposed access from Thorn Avenue to McNinch School asking if a gate was going to be placed so access can not be used when school is not in session. She also asked for patrol on Friday & Saturday nights, large trucks don't realize the street is a dead end. Manager Hendershot advised Ms. Conner that a gate will be placed to close the road when school is out. **NEW BUSINESS:** Discussion and Approval of Water Purchase Agreement Between the City of Moundsville Water Board and Marshall County PSD #4. Councilperson Lemasters made a motion to approve the Water Purchase Agreement, seconded by Councilperson Wood. Motion carried unanimously.
