Update on the 12th Street Sidewalk Project. A Department of Transportation grant was awarded to the City of Moundsville in the amount of \$64,000 for the 12th Street Sidewalk Project. Councilperson Lemasters made a motion to receive and file the grant certificate from the Department of Transportation, Transportation Enhancement Program, seconded by Councilperson DiRemigio. Motion carried unanimously. City of Moundsville 2004, 2005 & 2006 Audit Reports. The Audits for the years 2004, 2005 & 2006 have been received from the state. One major concerns from the Exit Report that needed addressed was the term of loans, which has been corrected. Additional Benches & Picnic Tables for Recreation Areas. Manager Hendershot announced that Councilperson Cunningham has been working on obtaining funds for new park benches and picnic tables for recreation areas in Moundsville. At present the City of Moundsville has received four park benches and one swing from funds donated by local businesses. Actuary Study of the Moundsville Police Department Pension. Information was received from the Actuary Study of the Police Pension showing the value last year was \$1,692,826.28 compared to the current value of \$2,092,260.39 an increase of \$400,000 in assets. Fire Department Applying for SAFER Grant. Chief Clarke will be applying for a SAFER Grant (Staffing for Adequate Fire and Emergency Response). The grant is for five year and the federal government supples matching funds on a sliding scale for four years and the city would have to absorb the total cost in the fifth year. This is per firefighter salary requested if approved.

The Moundsville Police Department has been tentatively awarded a \$75,000 grant from Congressman Alan B Mollohan that will provide funds for manpower, training and equipment needed to improve law enforcement. This bill have been passed through the Congress and is pending through the Senate. Fostoria Glass Project. The Marshall County Commission in support of the Fostoria Glass Project donated \$20,000 toward the Fostoria Glass Demolition. State of WV Funding. The City of Moundsville has received funding from the State of West Virginia for the 2008 Fourth of July Fireworks of \$5,000 and the 2008 Bass Masters Bass Tournament of \$4,000. Marshall County Youth Club. The Marshall County Youth Club is requesting a letter of support from the City of Moundsville to assist in applying for grant funding. Councilperson DiRemigio made a motion to send a letter of support for the Marshall County Youth Club, seconded by Councilperson Wood. Motion carried unanimously. Request for Abandonment at Center Street & Ash Avenue. The Church of God has purchased property on the west side of the alley at Center Street & Ash Avenue and has requested the alley be abandoned. Councilperson DiRemigio made motion to send this request to the Traffic Committee, seconded by Councilperson Lemasters. Motion carried unanimously. Police Lt. David Robinson to Retire. Manager Hendershot announced the retirement of Lt. David Robinson, in the near future, after 31 years of service to the City of Moundsville Police Department. **MAYOR ITEMS:** Mayor Wallace commented on the amount of dilapidated buildings & houses in the City of Moundsville. He hopes the city and residents can all do their part in keeping the city clean.

Manager Hendershot said the agreement has not been finalized through the Building Commission at this time.

- * Asked that the grass be cut growing through the fence at the Fostoria. Manager Hendershot will contact the contractors.
- * Reported that he spoke with Chief Kudlak and Manager Hendershot concerning the pigeon problem in Moundsville.

* Asked for an update on the vacant house on First Street across from Smith Mart. Manager Hendershot reported the owner was found, notified and should be making progress.

* Asked for an update on the closing of 7th Street. Manager Hendershot reported the problem is a Sanitary Board issue. Until about one week ago, the city did not know why the street was sinking. Traffic was not permitted on the street because of the potential dangers of the street

sinking. It was discovered the 22' deep sewer pipe had collapsed again. The Sanitary Board is in search of funding in approximately the \$500,000 range. The street will stay closed until it can be repaired.

* Any follow-up on Gordon's Property. Building Inspector Wise reported not at this time.

* Asked if the city can borrow money to pave streets? Manager Hendershot said the city probably could, but when you start paying interest you pave less streets the next time. Discussion was held on residents paying to pave their own streets.

* **DiRemigio** - Discussed how paving was done in the city several years ago when the citizens paid a portion and the city paid a portion of the paving.

* Congratulations to Lt. Dave Robinson on his retirement. Councilperson DiRemigio was Mayor when Lt. Robinson was hired as a patrolman.

* Commended the Fire Department on their training as First Responders.

* Councilperson DiRemigio made a motion to purchase the remaining vests for the Police Department now, seconded by Councilperson Wood. Motion carried unanimously.

* Asked if the city was aware of the contaminations at the Fostoria. Manager Hendershot advised that Protesta performed a site evaluation on the property showing where all the "hot spots" and contaminations are located.

* Lemasters - Asked for an update from 14 Potomac Street. Building Inspector Wise will meet with the owner on August 8, 2007.

* Asked for a work order for the property behind Dr. Shondrick's Animal Hospital on Lockwood Avenue.

* Requested the Dura Patcher on Water Street by the Horseshoe Courts.

* Reported potholes on Ninth Street.

* Reported a water problem on Myrtle Avenue at the Fairgrounds gate. Manager Hendershot advised they found the water drainage problem was the responsibility of the Fair Board.
