21 22 23	Councilperson Wood made a motion to accept and approve the minutes of the regular council meeting of September 4, 2007, seconded by Councilperson Simms. Motion carried unanimously.

CODE OF THE CITY OF MOUNDSVILLE TO PROVIDE REGULATIONS FOR OUTDOOR BURNING AND FIRES IN THE CITY. (SECOND READING)

Councilperson Lemasters made a motion to accept the outdoor burning and fires ordinance, seconded by Councilperson Wood.

Mayor Wallace called for a roll call vote. City Clerk announced the following tally. 5 yeas. Motion carried unanimously.

Discussion of Alterations to the Landfill Bridge.

The landfill bridge built last year with DEP funds and was part of the landfill closure possess is in need of alterations due to an ice jam that occurred behind the bridge last winter. Engineers from Department of Transportation suggested building ramps onto the up stream side of the bridge that would allow the ice as it collected to wash up over the bridge. The DEP was contacted and requested an extension on the grant process to allow funding to continue. Due to the weather and timing the engineer requested the city consider declaring this project an emergency purchase in order to have the alterations started before colder weather. If council wishes to use the bid process the advertisement, the bid could be back to council at the next regular council meeting.

Attorney White commented that city charter provides that anything more than \$10,000 has to be put out for bid. "In the event that of any emergency requiring immediate action, the council by resolution may waive the requirements for competitive bidding providing the resolution set forth the nature of the emergency and the necessity for the immediate action."

Mayor Wallace made a motion to declare this matter an emergency being necessary to protect the residents in the area from future flooding and to assure that council take immediate action before inclement weather, seconded by Councilperson Wood. Motion carried unanimously.

Other Items to be Discussed by Council.

 * Councilperson Lemasters brought to council's attention the request to replace asphalt at the Valley Fork Walking Trail for \$3700. Attorney White's expressed his opinion in using the Municipal Fee for paving the walking trail stated the ordinance specifically defines the use of the funds for street improvements and street lighting. Manager Hendershot noted there are some funds in the Street Department budget that could be used for the trail.

Councilperson Simms made a motion to replace the asphalt at the Valley Fork Walking Trail, seconded by Councilperson Lemasters. Motion carried unanimously.

Discussion and Approval of an Ordinance Pertaining to Outdoor Off-Premises Advertising Signs. (First Reading)
Attorney White read the following ordinance by title only to be passed by council on first reading:
AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE, WEST VIRGINIA, AMENDING AND REENACTING SECTION 1389.11 OF THE MUNICIPAL CODE OF THE CITY OF MOUNDSVILLE TO PROHIBIT OUTDOOR OFF-PREMISES ADVERTISING SIGNS WITHIN 500 FEET OF A PUBLIC PARK IN THE CITY. (FIRST READING)
Councilperson Simms made a motion to accept and approve the outdoor sign ordinance, seconded by Councilperson Lemasters.
Councilperson Simms asked if this ordinance will stop the billboard being erected near the Riverfront? Attorney White stated as long as they have met the criteria and application has been made on the permit the billboard can proceed.
Mayor Wallace called for a voice vote. City Clerk announced the following tally. 5 yeas. Motion carried unanimously.
