4 The Council of the City of Moundsville met in regular session in the Council Chambers on
5 September 15, 2009 at 7:00 p.m.

7 Meeting was called to order by Mayor David Wood.

8
9 Invocation by Councilperson Mark Simms.

10
11 Mayor Wood asked for a moment of silence for fallen Charleston Police Officer Jerry Jones.

13 City Clerk Hewitt called the roll and the following councilpersons were in attendance: DeWitt,
14 Haynes, Saunders, Simms, Wallace, Young and Mayor Wood. Also present: Acting City
15 Manager Deanna J Hess, Police Chief Kudlak, Fire Chief Clarke, Street Commissioner
16 Richmond, Building Inspectors Wise & Watson, CPA Kathryn Goddard, Attorney Thomas

23 Councilperson Saunders made a motion to accept and approve the minutes of the regular council
24 meeting of September 1, 2009, seconded by Councilperson Haynes. Motion carried

3 * Mayor Wood reported complaints from citizens concerning the noise of motorcycles late at
4 night & fighting outside the Boom Ground Club (Sherry's Redneck) on Arlington Avenue.

6 Chief Kudlak asked that council members advise their constituents to call the police department
7 when problems occur at the Club. However, officers have spoke to the bar owner and informed
8 them of the noise complaints. Chief Kudlak has also contacted the ABCC.

10 * Mayor Wood asked how the traffic flow on Tomlinson Avenue by Central School has been.
11 Chief Kudlak reported the traffic flow as being okay.

13 * Mayor Wood asked who the two newly hired officers were. Chief Kudlak reported the city
14 hired Sean Wilhelm and on Friday will hire Joseph Crow. Also, Brittany Poplawski has returned
15 from injured status.

38 1. The Traffic Committee Recommends Painting Curb Yellow on Tomlinson Avenue for Child
39 Pick Up & Drop Off.

41 Councilperson Simms made a motion to paint the curb yellow on Tomlinson Avenue for child
42 pick up & drop off, seconded by Councilperson Saunders.

44 Mayor Wood called for a voice vote. City Clerk announced the following tally. Saunders,

46 unanimously.

2. The Traffic Committee Recommends Changing all Commercial Handicapped Spaces to Two Hour Parking.

Councilperson Simms made a motion to change all commercial handicapped spaces to two hour parking, seconded by Councilperson Saunders.

Mayor Wood called for a voice vote. City Clerk announced the following tally. Simms, Wallace, Young, Mayor Wood, DeWitt, Haynes and Saunders. 7 yeas. Motion carried unanimously.

COUNCIL ITEMS:

* **Wallace** - Reported pot holes in the alley that runs east & west behind the library; Highland Avenue & Walnut Avenue; between 112 & 115 Morton Avenue; at 13th & Purdy Avenue; between 13th & 14th Street on Thompson Avenue.

* Reported the street light is still out in front of NAPA.

* **DeWitt** - Reported a dilapidated house at 1305 North Street should be 1307 North Street.

* Asked if Street Commissioner Richmond has the dates for the surveys on the alley between Ruby & Pearl Street and McKinley & Garfield Street. Street Commissioner Richmond reported not having the dates but the alley is marked.

* **Young** - Asked if the camera has been ran through the storm drain in the alley behind Center Street. Street Commissioner Richmond reported the camera was ran through the drain and showed no signs of collapsing.

* Reported the drain may need cleaned out in alley between 4th & 5th Street and Grant & Parriott Avenue.

* **Haynes** - Nothing at this time.

* **Saunders** - Wants to know why the grass at 1514 & 1516 Fourth Street has not been cut.

* Reported Ralph Taylor property at 3rd & Jefferson Avenue is still a mess. Fire Chief Clarke reported property is being addressed.

* Reported property at 7th & Magnolia Avenue is falling in. Fire Chief Clarke reported the property is being addressed.

* Received a complaint of Sanitation workers removing straps that a neighbor uses to keep his garbage can closed in Cherokee Hills.

1 * Asked for an update on the traffic light at 5th & Jefferson Avenue. Acting City Manager Hess
2 reported that DOH Jay Wallace left a message for the City Manager.

4 * Received a request from the Parks & Recreation Board concerning plastic/wood benches for
5 the ladies dressing room. Councilperson Saunders submitted an estimate for the benches.

7 * Received another request from the Parks & Recreation Board for more police patrol at East
8 End Playground & Swimming Pool.
