21	Councilperson Haynes made a motion to accept and approve the minutes of the regular council
22	meeting of October 21, 2009, seconded by Councilperson Saunders. Motion carried

25 26	GENERAL PUBLIC HEARING:
27	* Tom Hvizdos, OVRTA (Ohio Valley Regional Transportation Authority) spoke to council
28	about a bus levy for Moundsville. Mr. Hvizdos presented council members with copies of
29	information concerning the service currently available in Moundsville by OVRTA as well as an
30	estimate of the average monthly cost to residents if a local property tax levy were implemented.

32	* Mary Ellen Yoho, 1104½ Fifth Street reported the dumpster at 401 Grant Avenue being filled,
33	also broken glass and nails in the alley. She asked when council was going to do something
34	about this problem?
