* Councilperson Saunders asked Manager Hendershot if he had found out anything going on with the burned house on Curtis Avenue? Fire Chief Clarke reported the owner has obtained a demolition permit from the building inspectors which he intends on starting the job weather permitting.

* Councilperson Saunders asked if hydrants are being metered for the usage of water on Poplar
 Avenue. Manager Hendershot said the hydrants are being metered.

* Councilperson Young asked who monitors the traffic light at 1st & Jefferson Avenue? And asked for the light to be on flash during bad weather, vehicles stopped on the extension are having a hard time making it up the hill. Manager Hendershot advised that officers have a key and put the light on flash when the streets are bad.

* Councilperson Young asked that building permits be waived for residents in the 200 block of Poplar Avenue for repairs being done caused by the mine subsidence? Attorney White commented that the city could do something administratively.

Discussion and Approval of a Resolution to Authorize the City Manager to Enter into a Contractual Agreement for the City's Liability Insurance for 2010-2011.

City Manager reported that the city received their insurance update today which included a major increase in the premiums and he did not recommend approving the resolution.

Vice Mayor Wallace moved to table the resolution concerning the City's Liability Insurance until the City Manager can obtain other quotes, seconded by Councilperson Saunders.

* Councilperson DeWitt asked Chief Kudlak if he was going to be hiring more dispatchers since one of them took the secretary position. Chief Kudlak commented that he is up to staff but some illness fell on the dispatchers which left them short.

* Councilperson Saunders announced that he and Councilperson Haynes are in the process of raising funds for a new skateboard park at East End. They have picked out a design for the park and have contacted some potential sponsors.

* Councilperson Simms reported the traffic light at 10th & Lafayette Avenue is not changing for the east & west bound traffic.

* Councilperson DeWitt asked if the city has ever looked into the possibility of a Sam's Club in Moundsville? Manager Hendershot commented that it was considered when Walmart was built, but Sam's Club is geared more toward business than the private citizen.

* Mayor Wood asked City Clerk Hewitt if updates will be made to the city code. The City Clerk suggested that council members bring their code books to the office to be updated.

* Mayor Wood thanked the Street Department, Police Department and Fire Department for helping clear roads in the city.

* Asked for an update on the Fostoria site. Manager Hendershot reported entering into the contractual agreement with Thrasher Engineering who is working toward developing the abatement plan.

Councilperson Saunders asked what is the plan for the stacks that are still standing? Manager Hendershot reported GAB has stopped all demolition until the abatement plan in place. GAB has assured Manager Hendershot they will notify him before they demolish the stacks.

- * Asked for an update on the Sanford Center. Manager Hendershot reported the Board of
 Directors have physically filed the 501-C-3 paperwork with the state. The cost for submitting
 the application was \$400. The board is moving forward but there are a lot of things to be done.
- Another sale has been scheduled for February 27, 2010 from 9:00-11:00. Prices have bee reduced.

* Asked if the legislature was discussing any items that council should be aware of concerning municipalities. Manager Hendershot reported that legislatures were discussing annexation. The counties wish to open this discussion back up to make more restrictive laws for municipalities to conduct annexation. The WV Municipal League has been opposed to this and discussion has not been reopened by any of the legislative committees at this time.

Update on Planning Commission Members by Attorney White.

Attorney White was asked to research whether or not the Planning Commission must have 11 members by law. Mr. White reported that council may establish a commission of members between 5 and 15 members. If council wished to reduce the numbers of members, they will have to decide how they will phase out the present terms of the members already established.

Councilperson Simms made a motion to direct the City Attorney to draft an ordinance reducing the members from 11 to 7 members and a quorum consisting of the majority, seconded by Councilperson DeWitt. Motion carried unanimously.

Discussion of Presentation of Moundsville Volunteer Fire Department Budget for 2010-**2011.** The Finance Committee will make decision after the City Manager has presented the 2010-2011 General Fund Budget and Budget Message. 3. Discussion of 2010-2011 Proposed Budget. The City Manager will present the 2010-2011 General Fund Budget and Budget Message on February, 23, 2010 at 5:00 p.m. A Finance Meeting will follow the presentation of the Budget and Budget Message. 4. Discussion of Police and Fire Pensions. The Finance Committee instructed the City Manager to enact in the budget message the reduction of the Police and Fire pensions. Discussion and Approval of Recommendation by the Traffic Committee. There was no traffic meeting due to budget meetings Discussion and Approval of Recommendations by the Policy Committee. There was no policy meeting due to budget meetings. **COUNCIL ITEMS:** * **DeWitt** - Noted that the Dog Warden issue was not discussed under the Finance Committee. Manager Hendershot said that he can bring the cost projections to the next finance meeting. Mrs. DeWitt presented copies of emails she received from other cities. Councilperson Simms commented that he was not in favor of hiring a dog warden, but if there were four members interested that was fine. * Reported the sidewalks along the ballfields at East End and Fourth Street are unacceptable. They have not been cleaned since the snow. Councilperson Saunders disagreed with Councilperson DeWitt stating that he saw Tom Sutton and Charlie Wood using the snowblower and shoveling. * Young - Thanked the kids on Fourth Street for the hot chocolate they were selling.

1 2	* Saunders - Reported the Parks & Recreation Board is in the process of applying for grants for a new hot tub in the amount of \$40,000.

4	* Also, asked Attorney White if the contract for baseball, softball, soccer and swimming is
5	completed. Attorney White said that it was ready to be picked up.

7	* The Board is going to request that the Baseball Association be charged for trash removal
8	during the Beast of the East Tournament.

10	* The Board is not happy with the Swim Team that is using the pool because they are leaving it a
11	mess and not making the kids clean up after themselves.

13	* Wallace - Apologized to Councilperson Saunders for raising his voice during the Finance
14	Meeting.

16	* Haynes - Nothing at this time.

18	* Simms - Asked that Marshall County has become a Class I county reaching \$2 billion in asset
19	value. Since the county will be receiving 10% more in revenues Councilperson Simms
20	suggested the City Manager send a letter to the Marshall County Commission asking them to pay
21	for the bus service.
