AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE, WEST VIRGINIA, AMENDING AND REENACTING SECTION 345.35(F) OF THE CODE OF THE CITY OF MOUNDSVILLE, RELATING TO THE ENFORCEMENT AND PENALTY FOR VIOLATION OF THE CITY'S VEHICLE SAFETY BELT LAW, BY REMOVING THE PROVISION PROVIDING FOR THE SAME TO BE A SECONDARY OFFENSE. (FIRST READING)
