9 Invocation by Councilperson Mark Simms.

11 City Clerk Hewitt called the roll and the following councilpersons were in attendance: DeWitt,
12 D. Haynes, P. Haynes, Remke, Simms, Wood and Mayor Saunders. Also present: City Manager
13 Deanna J. Hess, Fire Chief Clarke, Police Chief Mitchell, Street Laborer Wallace, Building
14 Inspector Schneider, Kathryn Goddard, Attorney Thomas White, and City Clerk Hewitt.

18 **Regular Council Meeting of December 3, 2013.**

20 Councilperson P. Haynes moved to accept and approve the minutes of the regular council
21 meeting of December 3, 2013, seconded by Councilperson DeWitt. Motion carried unanimously.

25 Councilperson P. Haynes moved to accept and approve the minutes of the regular council
26 meeting of December 3, 2013, seconded by Councilperson DeWitt. Motion carried unanimously.

30 **Presentation of Christmas House Decorating Winners**

32 Mayor Saunders announced winners of the house decorating contest and presented award to Mr.
33 & Mrs. Wagner, 42 Walnut Avenue for Most Original. Not present: Crissy Markwas, 314 7th
34 Street for Most Decorative; and Denny Phillips for Honorable Mention.

36 * Mike Pierson, owner of Treasure Chest, 323 Jefferson Avenue, thanked the Police Chief and
37 council for making the requested changes in the Pawnbroker Ordinance. However, he questioned
38 section 731.07 (d) to include said persons address.

40 Council members understood eliminating the social security number but leaving the address.
41 Since members were not sure of the decision they decided to discuss the issue again at the Policy
42 Meeting.

3 **Discussion and Approval of an Ordinance Pertaining to Section 731 of the City Code**
4 **Concerning Pawnbrokers. (Second & Final Reading)**

5
6 Attorney White read the following pawnbroker ordinance by title only to be passed by council on
7 second and final reading:

9 **AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE, WEST**
10 **VIRGINIA, AMENDING AND RE-ENACTING SECTION 731 OF THE MUNICIPAL**
11 **CODE OF THE CITY OF MOUNDSVILLE TO PROVIDE FOR REGISTRATION,**
12 **LICENSING AND REGULATION OF SECONDHAND DEALERS AND**
13 **PAWNBROKERS IN THE CITY OF MOUNDSVILLE. (SECOND & FINAL READING)**

15 Councilperson Simms moved to table ordinance until further discussion, seconded by
16 Councilperson Remke. Motion carried unanimously.

18 **Discussion and Approval of an Ordinance Pertaining to Section 361.03 of the City Code**
19 **Concerning Parking in the "Parkway" of the Sidewalk. (Second & Final Reading)**

21 Attorney White read the following ordinance by title only to be passed by council on second and
22 final reading:

24 **AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE, WEST**
25 **VIRGINIA, AMENDING AND RE-ENACTING SECTION 361.03 OF THE CODE OF**
26 **THE CITY OF MOUNDSVILLE, TO PROHIBIT PARKING ON THE SPACE**
27 **BETWEEN THE CURB AND SIDEWALK OF A CITY STREET (SECOND & FINAL**
28 **READING)**

30 Councilperson Simms moved to accept and approve the above ordinance on second reading,
31 seconded by Councilperson P. Haynes.

33 Mayor Saunders called for a voice vote. City Clerk announced the following tally. 7 yeas.

42 the Skatepark Committee has applied for a grant and they in the process of ordering skate rails.

7 Councilperson Wood moved to nominate Eugene Saunders for Mayor, seconded by
8 Councilperson Simms.

9
10 Councilperson Haynes moved to close nominations , seconded by Councilperson Dewitt. Motion
11 carried unanimously.

12
13 Motion was made and seconded nominating Eugene Saunders for Mayor. 7 yeas. Motion carried
14 unanimously.

15
16 **2014 Election for Vice Mayor.**

18 Councilperson DeWitt moved to nominate David Wood for Vice Mayor, seconded by
19 Councilperson D. Haynes.

20
21 Councilperson Remke moved to close nominations, seconded by Councilperson DeWitt. Motion
22 carried unanimously.

23
24 Motion was made and seconded nominating David Wood for Vice Mayor. 7 yeas. Motion
25 carried unanimously.

27 **Discussion and Approval of Resolution to Authorize the Contract for West Virginia**
28 **Governor's Community Grant Participation Program Funds (Park View Playground)**

29
30 Councilperson Remke moved to approve the resolution authorizing the City Manager to enter
31 into a contractual agreement with the WV Governor's Community Participation Program for a
32 grant in the amount of \$10,000 for Park View Playground, seconded by Councilperson P.
33 Haynes. Motion carried unanimously.

35 **Discussion and Approval of Awarding Bid for Sale of Used Vehicle.**

37 A bid was received from A-1 Auto Parts in the amount of \$1111.00 for a 1984 Ford CTV Van.
38 Councilperson Remke moved to award the bid to A-1 Auto Parts, seconded by Councilperson
39 DeWitt. Motion carried unanimously.
