Meeting was called to order by Mayor David Wood.

Invocation by Councilperson Allen Hendershot.

Before invocation, Councilperson Hendershot asked everyone to take a moment of silence for Ssgt Ryan D. Hammond, USAF, a Moundsville resident, who lost his life while serving our country.

City Clerk Hewitt called the roll and the following councilpersons were in attendance: DeWitt, Hendershot, Saunders, and Mayor Wood. Absent: D. Haynes, P. Haynes and Simms. Also present: City Manager Deanna J. Hess, Corporal Joe Crow, Fire Chief Clarke, Street Commissioner Stocklask, CPA Kathryn Goddard, Attorney Thomas White, and City Clerk Hewitt.

MINUTES:

Regular Council Meeting of September 15, 2015.

Councilperson Saunders moved to accept and approve the minutes of the regular council meeting of September 15, 2015, seconded by Councilperson DeWitt. Motion carried unanimously.

Special Council Meeting of September 22, 2015.

Mike Anderson - 5K Run Walk for Isaiah Leasure.

AN ORDINANCE OF THE CITY OF MOUNDSVILLE, WEST VIRGINIA, PROVIDING TO CHANGE A CERTAIN DESIGNATED AREA OFF TWELFTH STREET IN THE CITY OF MOUNDSVILLE FROM A SPECIAL CONSERVATION ZONE TO A HIGHWAY COMMERCIAL AND INTEGRATED COMMERCIAL CENTERS ZONE. (SECOND READING)

Councilperson Saunders moved to accept and approve the zone change ordinance, seconded by Councilperson DeWitt.
